Please join us on October 27 for “Let’s Talk Details: a Deep Dive with Medical Aid-in-Dying Navigators.” This is the seventh in our educational series on implementing Hawai‘i’s Our Care, Our Choice Act (OCOCA) and models for normalizing and integrating end-of-life choices into standard medical care.

This session will focus on case examples from experienced Hawai‘i nurse and social worker navigators, who will share key learnings, challenges, and best practices from their nearly 3 years of practice under the law.

Learn about the navigator’s role in supporting both patient and providers in the medical aid-in-dying process, including partnering with hospice, being non-judgmental, providing education, coordination, and resources, and being present at the patient’s death if requested. Gain an understanding of the importance of training others by sharing experiences and facilitating staff debriefs after a case. Hear illuminating examples of patient and family conversations regarding medical aid in dying from experts Susan Amina, Nurse Practitioner, Kaiser Permanente; Michelle Cantillo, Registered Nurse & Advance Care Planning Coordinator, Hawaii Pacific Health; and Jodi Shaw, Licensed Social Worker, CCM, OSW-C, APHSW-C, Kaiser Permanente.
