

## OFFICIAL RULES FOR HAWAI'I PACIFIC HEALTH 2021 VIRTUAL WOMEN'S 10K & 5K FUN RUN "GIRL ON THE GO" SOCIAL MEDIA CONTEST

No purchase necessary. A purchase will not increase your chances of winning.

- 1. Eligibility: Hawai'i Pacific Health's "Girl on the Go" Instagram photo and video contest is open only to legal residents of Hawai'i who are at least eighteen (18) years old. Employees of Hawai'i Pacific Health and its affiliates are not eligible to enter. The Contest is subject to all applicable federal, state and local laws and regulations. Void where prohibited.
