

**Official Rules for Hawai'i Pacific Health UH Baseball Sweepstakes**  
**No Purchase Necessary. A Purchase Will Not Increase Your Chances Of Winning.**

**Eligibility:** The Contest is open only to legal residents of Hawai'i who are at least eighteen (18) years old. Employees of Hawai'i Pacific Health ("Sponsor") are not eligible to enter.

**How to Enter:** Post a picture or video on Instagram or Twitter showing how you create a Healthier Hawai'i. A post could be your favorite recipe or ways you stay active. It could be anything that shows how you stay healthy. Make sure to follow Hawai'i Pacific Health on the social channel you are entering on and tag your entry with #HealthierHawaii. Accounts must be public for us to see your entry. Entries must be received by 11:59pm on April 30, 2017 to be eligible.

**Judging:** Sponsor will randomly select one (1) potential grand prize winner and three (3) runner-ups from all entries received. The odds of being selected depend on the number of entries received. Sponsor will attempt to notify the potential winner shortly after a winner is chosen.

**Potential Winner Requirements:** A potential winner's original photo must follow the rules of the Sweepstakes. Except where prohibited, a potential winner may be required to complete and return an affidavit of eligibility, and a liability/publicity release. If a potential winner fails to sign and return these documents within three (3) days after they are sent, Sponsor may select an alternate potential winner in his/her place from the remaining entries received. Only three (3) alternate potential winners may be contacted.

**Prizes:** One (1) grand prize winner will receive four (4) tickets to the UH Baseball game on the dates between May 5-7, 2017 at Murakami Stadium, one (1) Healthier Hawai'i baseball cap and a chance to throw the first pitch. Three (3) runner-ups will receive two (2) tickets to the UH Baseball on the dates between May 5-7, 2017 at Murakami Stadium, and one (1) Healthier Hawai'i baseball Prize will be picked up at Murakami Stadium's box office. The approximate retail value of the grand prize is \$70. The approximate retail value is \$24. Any prize details not specified above will be determined by Sponsor, in its sole discretion. A prize may not be transferred and must be accepted as awarded. A winner may not request cash or a substitute prize; however, Sponsor reserves the right to substitute a prize with another prize of equal or greater value if the prize is not available for any reason, as determined by Sponsor, in its sole discretion.

Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt of that communication by Sponsor. The Sweepstakes is subject to federal, state, and local laws and regulations and is void where prohibited.

You further agree that in any cause of action, in no event shall the Released Parties be liable for attorney’s fees. You waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

**Disputes:** You agree that any and all disputes, claims, and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Honolulu, HI.
